A report on the inspection event «Inspection of Effectiveness and Efficiency of Spending of Federal Budget Monies and Monies of the Republic of Kalmykia, and Efficiency of Inter-budgetary Relationships and Compliance with Provisions of Federal Law No. 131-FZ dated October 6, 2003 «On General Principles of Local Government in the Russian Federation» as Pertaining to the Republic of Kalmykia».

The goal of the inspection event was to organize the budgeting process; check for compliance of legislative and other normative acts regulating budgetary relations in the regional budget with federal legislation; monitor budget performance in part of profits from tax and non-tax income, as well as uncompensated and irrevocable transfers from the federal budget; monitor budget performance in part of expenses in terms of fullness and timeliness of financing, verifiability of accounting and reporting, efficiency of target financing, including subventions allocated in 2006 from the federal budget into the Republican budget for the purpose of managing, regulating and protecting water biological resources, etc.
